What is Automatic Cash Application Rate?

The number of payments received by the company that are automatically matched to invoices divided by the total number of payments received by the company over the same period of time, as a percentage.



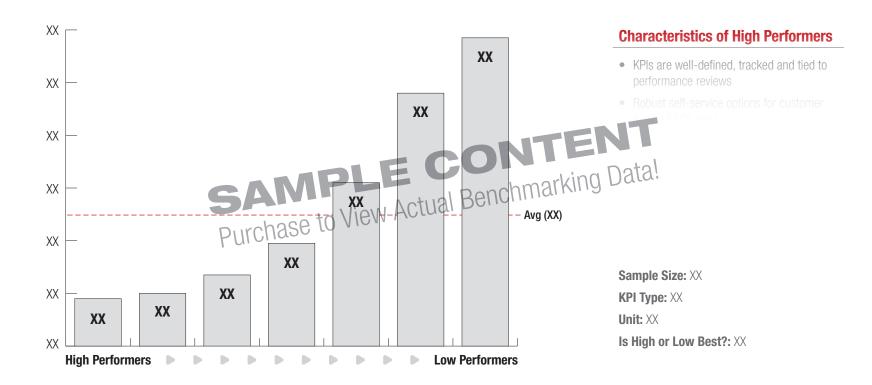
